### WESTSIDE QUILTERS EXECUTIVE BOARD MEETING FEBRUARY 27, 2016

A meeting of the Executive Board of Westside Quilters was held on February 27<sup>th</sup>, 2016 at the home of Sally Wright.

President Perla Rothenberg welcomed everyone and called the meeting to order at 10:05 a.m. Other Officers attending were Sally Wright, Tina Nord, Luann Jaffe, Debbie Nussbaum, Roberta Walley, KarynnDittmar, Kathryn Pellman, Sue Woods, Hilary Smith, and Lisa Drew.

The motion to approve the minutes of the January 16<sup>th</sup>, 2016Executive BoardMeeting was made by Luann Jaffe seconded by Roberta Walley and approved by all.

Vice President's Report: Debbie Nussbaum talked about the Executive Board positions that will be open when current Board members term-out. These are President, Secretary and Treasurer. Debbie asked the Board Members who have completed one year of their term if they would continue to serve in their current positions. They will let Debbie know as soon as possible. Debbie asked the Board for suggestions of guild members who might be interested. Tina recommendedthat the outgoing treasurer train the incoming treasurer and that they have a Quicken or QuickBooks background. Lisa Drew (secretary) and Tina Nord (treasurer) offered to continue for another year if replacements cannot be found. If necessary, a resolution to continue terms for one more year will be presented at the General Meeting. The Executive Board will approve the slate of new and continuing officers at the April meeting.

**Membership Report:** KarynnDittmarreported that WQ currently has 90 guild members. This number includes two new members, Gwendolyn Spaulding, Susan Irving and returning member Veronica Gray. Membership renewals will begin in May.

**Website / Social Media:** Sally Wright talked about the website. On March 24<sup>th</sup> the website will be active for 5 years, the domain name has to be renewed at a cost of \$65. Show and Tell and workshop photos are on the website.

**Treasurer's Report:** Tina Nord reported that the cash balance is currently \$5537. Culver City still owes a room deposit refund of \$300. WQ purchased a new microphone/sound system for \$234. The January UFO workshop resulted in a profit of \$64, and the Luke Haynes February workshop a profit of \$251. Tina reported that as the close of the fiscal year approaches, expenses for the 4 quarterly meeting are estimated at \$4000, \$200 below budgeted. Income from workshops is estimated at \$7200 against \$6800 predicted. Expenses for workshops are estimated to be \$7300 against \$7200 budgeted.

**Newsletter:** Luann Jaffe reported that the upcoming newsletter is ready to be sent out.

**Philanthropy:** Sue Woods received a letter offering the donation of an antique quilt. A notice will be put in the newsletter. Hilary Smith has collected nine more baby quilts and one wounded warrior quilt. Sally and Roberta volunteered to deliver the wounded warrior quilts. WQ labels will be sewn on at the next meeting. Madeline Ehrlich will be contacted regarding suggestions for a workshop scholarship recipient.

**Programs:** Sally Wright talked about upcoming programs. There are three workshops open for registration. At present the Kathryn Pellman and Cindy Myers workshops have 11 members signed up, and Jerry Granata, 10. Another email regarding these workshops will be sent out.

Roberta talked about workshop and lecture feedback. Parking issues at St. John's Presbyterian were also addressed.

Other Guild Business: The legal and accounting ramifications of the donated HandiQuilter 16 were discussed. Tina reported that according to the IRS, the donor is responsible for the delivery of the gift to the recipient and providing ownership documentation. If the item is worth in excess of \$5000 the donor must submit appropriate documentation to the IRS. The gift must be used for charitable purposes. The question of insurance was raised and although WQ owns the long-arm whoever has it set up on their property is responsible for property and liability insurance. An official valuation of the machine has not yet been received; Hilary will call to set up a valuation. When this is received the donor will be given the option to reclaim the HQ16 if they are not happy with the amount allowable as a taxable deduction. If the HQ16 stays with the Guild, members will be offered the opportunity to purchase the machine.

The next Executive Board meeting will be held at the home of Sally Wright on April 2<sup>nd</sup> at 10am.

The meeting was adjourned at 12 p.m.
