

tracing, shading and inking onto fabric, working from your own photographic paper prints (any subject matter). Using textile inks, markers, pencils, pastels and other materials, discover fun, easy design and drawing exercises to achieve realistic imagery in your guilts. You will explore design elements geared for the specific application of your individual projects, and you will create a master pattern from your own images.

Emphasis is on individual applications of techniques, and the fun of developing your own style. No prior art experience necessary, but those with an art background will learn specific applications for achieving beautiful imagery on fabric. All the information including the supply list is

Lura Schwarz Smith has a Bachelor of Arts degree in Art from San Francisco State University. As well as graphic and illustration art, she has been producing art



quilts since 1975, originally showing in California galleries throughout the 70s and 80s. In the 90s she showed quilts and received awards at regional, national, and international guilt shows. . She has had one of her guilts named one of the "100 Best American Quilts of the 20th Century," and she was included in the "30 Distinguished Quilt Artists of the World" exhibit at the first Tokyo Dome quilt show in 2002 in Japan.

In recent years, Lura has shifted her focus to art quilt venues, galleries and museums. Her work has been juried into many prestigious art quilt shows such as Quilt National, Quilt Visions, SAQA's Creative Force, Quilts=Art=Quilts, and other gallery and museum shows. Her work is in private collections across the country. She is a member of the Yosemite Western Artists, Sierra Mountain Quilters, and a juried artist member of Studio Art Quilt Associates. PHILANTHROPY

Philanthropy Committee update:

- 1. Another 18 quilts were delivered to St. Joseph's Center in Venice the week of June 20th. They "ooohed and aaah-ed" over the quilts and were so appreciative of the work each of you put into the quilts and the support they have received from the Westside Quilters guild.
- 2. A note was received thanking the Guild for the patriotic quilts that were received at the hospital in Germany for the service men and women who give so much for our country. (Note: there were some questions from our members re: the recent news about the Wounded Warriors organization. Our quilts have nothing to do with that group. Our quilts are given to Quilts for Wounded Warriors and are delivered directly to the staff at the hospital.)
- 3. Several suggestions were mentioned on the surveys and we have followed-up with *Dollies Making a Difference* and with *ImagineLA*. (Information about both these groups is available on their individual websites.) Sylvia Davis volunteered to teach a workshop and her generous offer was referred to the Program Committee. We are continuing to follow-up with your remaining suggestions in addition to maintaining contacts with the organizations and schools we supported this past year. Your responses, comments and suggestions were appreciated.

Thank you for making this past year such a success and the focus for this next year will be presented at the General meeting in August. If you are working on quilts – or have completed quilts – please continue and bring completed quilts to the next meeting. We will definitely make sure they are delivered to the appropriate group.

WESTSIDE QUILTERS EXECUTIVE BOARD MEETING June 11,2016

The Executive Board Meeting of Westside Quilters (WQ) was called to order by President Perla Rothenberg at Sally Wright's home at 10:15 a.m. on **Saturday**, **June 11**, **2016**. Members of the 2015 and 2016 executive boards were in attendance. Vice President Debbie Nussbaum thanked new board members for joining and expressed thanks to those members whose terms had expired.

Minutes of the April 2, 2016 Executive Board Meeting, previously submitted by e-mail to the Board, were unanimously approved.

Karynn Ditmar reported that a little over one-half of the members have renewed for the 2016-2017 year. August 1 is the deadline, and last year almost all memberships were complete by then. The membership form will be in the July Newsletter. Sally Wright will need to have up to date contact information for members in order to notify everyone of the new password for WQ's website.

Sally Wright noted that the new version of WQ by-laws will be up soon, and that all new officers are on the website. She requested that officers respond to an e-mail she will be sending to verify that officers' e-mail addresses are correct.

The Treasurer's report was handled by both Tina and Patti. According to Tina, WQ's June 11, 2016 balance is \$6,862. This amount reflects the \$900 paid for the June teacher and venue fees. Tina noted that Culver City still has not returned WQ's \$300 deposit from September, 2015. A letter has been written and other contact made, but the refund is still owed to WQ. WQ's profit for the 2015-2016 fiscal year is an estimated, \$1,165.

Tina noted that money comes in to WQ for future workshops, well before expenses for those workshops have been incurred. This skews WQ's treasury balance and makes it look healthier than it is. Tina strongly suggested that all

officers use the WQ debit card when possible. This would reduce the need for small reimbursement checks to various members for expenses.

Patti will be the Treasurer to contact in the future. She introduced the Bank Resolution confirming signatories for Westside Quilters: President Kim Ryan, Vice President Deborah Nussbaum and Treasurer Patti Post - were presented to the Board. It was seconded by Perla Rothenberg. Patti has the debit card number and will use it to pay the for web host company. All expenses up to \$200 require approval of the Board. Any amount over \$200 requires the Guild's approval. Patti is looking into getting a Square Reader.

Both Luann and Aileen did not attend the meeting, so there was no Newsletter report.

Sue and Carol indicated that only 7 surveys handed out at the meeting were returned to them. They are hoping for more input. Several philanthropy opportunities were discussed including "Dollies That Make A Difference". Our Showcase speaker at the August 20th meeting will present the Dollies That Make A Difference program to the Guild. Philanthropy will focus on Dollies and baby quilts for the November Philanthropy workshop. Members will still be encouraged to review the list on the website and make quilts for groups listed there, children, veterans, etc. A Fischer house is coming to the VA, and they may require more quilts. Originally the thought was that members would provide ideas which would then be available to everyone on the WQ website.

Hilary requested clarification of the workshop scholarship which Philanthropy can give out. The scholarship is meant for people who wouldn't ordinarily come to a workshop or for whom the cost would be problematic, or for someone who might teach the material to another person or group, or as thank you to those who have given time to the Guild. It is possible that the August workshop might not be appropriate for a student. It was suggested that Madeline Ehrlich might know a resource.

Sally Wright indicated that the August workshop with Lura Schwarz-Smith only has 2 people signed up. This is a two day workshop and it will be marketed to Quilts On the Wall, SAQUA and other art quilt groups after the WQ Newsletter is published in July. Sally will take the workshop sample to Quilts on the Wall in July. The Glam Clam workshop was a success, but WQ is losing money on workshops. One problem is our membership pool is relatively small. Sally will send out e-mails to previous members, and Kim Ryan will review old rosters for names for follow-up. Tina pointed out that WQ may have too many workshops and may need to vary what's offered by including trips, technique workshops, something that can be offered for a lower price. It was decided that the September workshop should be a Sew In with some members showing special techniques at set times. Additional details, pot luck, pattern, to be determined.

Lisa will be handling the Fabric Sale at the August meeting with help from Kim and Aileen. An announcement will appear in the Newsletter. It was suggested that the marketing for the Fabric Sale should encourage people to see the sale as a Fundraiser, not a give-away. Use "Suggested Donation", etc. The Church will be contacted to ask if WQ can have the church later than usual, and to make sure there are no other functions that morning

Diane Bell, the original owner of the long-arm quilting machine that was donated to WQ has been sent a letter acknowledging the donation of a HQ16 long arm quilting machine referring her to IRS Publication 561 "Determining the Value of Donated Property", which states a donor is obligated to secure an official appraisal of any item estimated value of \$5,000 or more. She valued the machine to be in the \$5,000 -\$5,400 range. The next question is how does WQ support the machine? It was decided to use the machine for 6 months and to revisit the actual value of it to WQ at that time.

Sally Wright advised the Board that she has one more year of Board membership, ending May 31, 2016, and she would like the Board to begin trying to find someone to replace her on the Programs Committee and someone to handle the Website.

The next WQ Board meeting will be August 6, 2016 at 10:00 a.m. at Sally Wright's home.

Meeting adjourned at 12:35 p.m.

WESTSIDE QUILTERS QUARTERLY GENERAL MEETING - MAY 14, 2016

The general meeting of Westside Quilters (WQ) was held on May 14th, 2016 at St. John's Presbyterian Church.

Introductory Remarks: President Perla Rothenberg brought the meeting to order at 10.05 am welcoming everyone. **Minutes:** A motion to pass the minutes of the February 16th, 2016 meeting was made by Madeline Ehrlich, seconded by Marianne Simpson and approved by all.Perla requested that members renew their membership today and to please add a donation if possible.

Perla acknowledged and thanked the Executive Board members for their service, and Stephanie Wexler, Ann Chach, Sue Correll, Sally Madigan, Bobbi Leung and Jean Donelan for their help on committees this year. Perla thanked Tanya Heldman for her help with photography.

The "fabric extravaganza" event will take place at the August quarterly meeting. Notions, magazines, and books will be added this year. Members were asked to save fabric and items for the event.

Guild Business:

Treasurer: Tina Nord reiterated that Executive Board members are voted in for one year at a time but will usually serve for two. A motion to approve Sally Wright continuing as Website manager was made by Perla, seconded by Madeline Ehrlich and approved by all. The current bank balance is \$3899. This includes an expected deposit return from the City of Culver City.

The budget for the new fiscal year was previously emailed to the Executive Board. This fiscal year a breakeven budget was projected. We are now expected to show a profit of \$1800 thanks to more individual donations and more profit from the fabric giveaway donations than anticipated, and the pro bono accounting review.

Perla called for approval of the budget for the new fiscal year, it was seconded by Marianne Simpson and approved by all. **Vice President:** Debbie Nussbaum announced and welcomed the incoming Executive Board members: Kim Ryan will be the new President; Sally Madigan will be Secretary and Patti Post Treasurer. Board members continuing are Karynn Dittmar – Membership; Aileen Cooke and Luann Jaffe – Newsletter; Roberta Walley, Sally Wright and Kathryn Pellman – Program Chairs; Carol Kapuscinski, Hilary Smith and Sue Woods – Philanthropy; Sally Wright – Newsletter; Perla Rothenberg – President Emeritus and Debbie Nussbaum – Vice President.

A motion to accept the new slate of officers was made by Madeline Ehrlich, seconded by Marianne Simpson and approved by all. Debbie thanked Perla for a wonderful job as President organizing and keeping the Guild meetings on track.

Philanthropy: Sue Woods thanked guild members for a successful philanthropy year. Sue requested that members fill out a form provided asking for suggestions regarding the organizations to which the Guild donates quilts. Philanthropy is looking forward to another exciting year ahead and the Philanthropy Workshop will be held on November 12th.

Membership: Karynn Dittmar requested that members sign up as soon as possible for the new membership year that runs from June 1st to May 31st 2017. Any additional donation made is a fully tax-deductible charitable donation.

Showcase Speakers: Roberta Walley and Sally Wright spoke about future Guild events. Sally showed a PowerPoint presentation and talked about the exciting upcoming programs. A brochure was also available listing all of the programs and events. Roberta and Sally thanked members for the responses and suggestions they had previously received, and have done their best to accommodate requests for specific teachers although not all are available or will travel.

Roberta thanked Sally for the brochure and PowerPoint presentation and asked members to please support the workshops. To keep the fees for workshops as low as possible member attendance is needed to cover expenses such as teacher transportation, accommodation, fees, and room rentals. Roberta emphasized that attending workshops is a great learning experience and encouraged all members to attend and consider workshops a priority.

Sally and Roberta also talked about their delivery of 8 Wounded Warrior quilts made by guild members. Sally thanked Jerry Granata for Friday's workshop. The Latifah Saafir and Lura Schwarz Smith were open for registration.

Further Guild Business: Stephania Bommarito reported that the Mancuso show in Palm Springs in October is looking for quilts.

Quilters by the Sea are selling tickets for their raffle quilt.

Show and Tell: Aileen Cooke showed "Cat Ladies" from the Kathryn Pellman "Fashionistas" workshop; Kim Ryan showed "Plunge Bunnies" Fashionistas, her Luke Haynes workshop log cabin art quilt and "Crosses"; Luann Jaffe a sashed hexagon quilt; Madhu Mandavia her Cindy Myers class quilt; Nancy Sharpe - "Amish Baskets"; Sylvia Davis – "Illusion #3"; Sandy Lauterbach – "3 'cans", "Peacock" and "Red Jasmine". Sally Wright showed her Cindy Myers project, a Susan Brubaker inspired painted whole cloth piece, and her finished Jenny Bowker inspired piece;

Stephania Bommarito a 16 patch quilt and a zentangle quilted piece; Sandy Abramowitz her Luke Haynes class quilt and a disappearing 9 patch; Pam Johnson her Fashionista piece and her cube project from the Jerry Granata class; Toni Glick her "Jamming Jellyroll" quilt. Virginia Marshall showed "Elephant Walk"; Maureen Gardner "Grandma's Garden" and "Ghost Elephants"; Debbie Nussbaum showed 2 "Fashionistas" pieces and her Cindy Myers workshop table runner; Brenda Gottfried her Jerry Granata cube; Roberta Walley showed her Lenore Crawford inspired "Street" wall quilt; Perla Rothenberg her diagonal zigzag quilt. Tina Nord showed her mystery quilt from the Charlotte Agnotti class and then presented Fred Zerez with a beautiful quilt she had made from Roberta Walley's design.

Featured Speaker: Sally Wright introduced our featured speaker Jerry Granata and thanked him for the wonderful workshop the day before.

Jerry presented his inspiring lecture "The Mantality of Quilting". Jerry took us on a journey through his quilting life that began with his sister teaching him to sew baby clothes in the kitchen of his mother's restaurant in Chicago Illinois. He later worked making clothes for marionettes and this is where he transitioned to using unusual fabrics. He made his first quilt in 1976, which he turned into a shower curtain. He served in the U.S. Navy as a musician for 21 years and performed in over 40 different countries. As he travelled the world he collected fabrics including silks, brocades and velvets. He also performed on Broadway. Jerry was inspired to start making art quilts by Frank Lloyd Wright's work specifically the windows. He moved to Florida, joined a guild and began to enter his work into shows. His love of art deco was also an inspiration and Erte inspired "Samson & Delilah". His quilt "Fly Me to the Moon" won first place at Houston. Jerry enjoys using different fabrics and threads in his work and is currently focusing on machine embroidery. Sally thanked Jerry Granata and Sherry Kleinman for her "Spoonflower" demonstration. She also thanked Fred Zerez for his service to the Guild.

The next General Meeting will be held on August 20th, 2016 The meeting was adjourned at 12.30. Submitted by
